

For persons who had their home or car damaged from the heavy rain on June 2, 2023 and are having trouble going to work.

① Regarding the disaster certificate

You can consult about the disaster certificate.

The disaster certificate is a record of the damages regarding your home.

Your home will be inspected and deemed either fully damaged (more than half damaged) or half damaged.

Consultation Locations

Please consult at your nearest city hall or town hall.

② For persons whose home is uninhabitable due to disaster damage. You may receive compensation up to 2 million yen.

③ For persons who developed a psychiatric disorder or were injured from the disaster. You may receive compensation up to 2.5 million yen.

④ For persons who had their home damaged or were injured from the disaster. You may receive compensation up to 3.5 million yen.

⑤ Prefectural Taxes

If your home, car, or business was damaged from the disaster, the following options may be available.

- 1 The deadline for prefectural taxes may be extended.
- 2 Your prefectural taxes may be adjusted.
