Here are the key points converting a foreign driver's license to a Japanese one!

(Procedures) (check & point)

- Reception (every Wednesday)
- · Not open on national holidays.
- We cannot accept your application if you forget to bring any of the required documents.
- No reservation required.
- All explanation is in Japanese.







- You cannot have the interview if you do not bring all the required documents.
- It is in Japanese.
- If you do not understand Japanese, you will need an interpreter.
- You will be asked about the license issuing procedure in the country where the license was obtained.
- Valid foreign license
- Expired licenses cannot be processed.
- ♦ Stay for a total of 3 months or more in the country where license was obtained
- Please prove the period of stay with your passport, mariner's pocket-ledger, certificate of employment, school certificate, pay slip statement, etc.
- Japanese immigration entry and exit stamps do not prove your stay.



Eye test etc.



- There is an eyesight test. Please bring glasses if you need them.
- There is a physical examination. Please let us know if you cannot move any part of your body.





Confirmation of Traffic Regulations Knowledge

- There are 10 questions. The pass mark is 7 and over.
- You have a choice of 20 languages.







- There is a driving test in the inside course of the driver's license center.
- Check whether you can drive according to traffic rules.
- Practice at a driving school, etc. before the test and get used to Japanese traffic rules.
- Mistakes such as driving on the right hand side, going off the road, ignoring stop signs, lack of safety checks and steering too sharply and collisions will result in a failed test.
